

NCAA® #GEARUPFOROMAHA GIVEAWAY
Official Rules

NO PURCHASE OR MOBILE TWEETING IS NECESSARY TO ENTER OR WIN. A PURCHASE OR MOBILE TWEETING WILL NOT INCREASE YOUR CHANCES OF WINNING.

The NCAA® #GearUpForOmaha Giveaway (the “Sweepstakes”) starts on May 21, 2014 at 12:00 a.m. Eastern Time (“ET”) and ends on May 25, 2014 at 11:59 p.m. ET (“Sweepstakes Period”). The Sweepstakes Period will be divided into five (5) daily entry periods (each, an “Entry Period”) as detailed in the chart below.

ELIGIBILITY: Sweepstakes is open to legal residents of the 50 United States and the District of Columbia, who are 18 years of age or older. Employees of the National Collegiate Athletic Association (“Sponsor”), Jarden, Inc. and their respective parents, subsidiaries, affiliates, promotion and advertising agencies, and members of their immediate families (spouse and parents, children and siblings and their respective spouses, regardless of where they reside) and persons living in the same household, whether or not related, of such employees, are not eligible to enter or win. May 22, 2014: Visit www.facebook.com/NCAACWS?ref=hl, “like” the NCAA® Baseball Facebook page, locate the “Tag Up Trivia” question post and submit a comment with the correct answer to the question to receive one (1) entry into the Entry Period 2 drawing.

May 23, 2014: Log-in to your Twitter account and follow @NCAACWS, if you are not already a follower. Then, locate @NCAACWS’s Sweepstakes tweet (marked with the hashtag #GearUpForOmaha) and favorite, retweet (RT) and reply to the Sweepstakes tweet to receive one (1) entry into the Entry Period 3 drawing.

May 24, 2014: Visit www.facebook.com/NCAACWS, “like” the NCAA® Baseball Facebook page, locate the “Caught Looking” photo posted and provide a caption to the photo by commenting to receive one (1) entry into the Entry Period 4 drawing.

May 25, 2014: Log-in to your Twitter account and retweet (RT) the “Grand Slam” tweet (marked with the hashtag #GearUpForOmaha) to receive one (1) entry into the Entry Period 5 drawing.

Entries may not contain, as determined by the Sponsor, in its sole discretion, any content that:

All entries must be received by 11:59 p.m. ET on the applicable Entry Period day to be eligible for the applicable Entry Period. Entries generated by script, macro or other automated means and entries by any means which subvert the entry process are void. Limit one (1) entry per

person and per Twitter account/Facebook account per Entry Period. Entries received from any person, Twitter account or Facebook account in excess of the stated limitation will be void. All entries become the property of Sponsor and will not be acknowledged or returned. A Twitter account and/or Facebook account are required to enter this Sweepstakes and are available for free at <http://twitter.com> and <http://facebook.com>, respectively. If you choose to tweet or otherwise participate using your mobile device, data rates may apply. See your wireless service provider for pricing plan details. You understand that you are providing your information to Sponsor and not to Facebook or Twitter. Sponsor's clock is the official timekeeper of this Sweepstakes.

RANDOM DRAWING: On or about the Drawing Dates indicated in the chart above, Sponsor will select one (1) potential winner for the applicable Entry Period in a random drawing from among all eligible entries received for the applicable Entry Period. Non-winning entries from one Entry Period will not carry over into any subsequent Entry Period(s). Odds of winning depend on the number of eligible entries received for the applicable Entry Period.

WINNER NOTIFICATION: Each potential winner will be notified via direct message from @NCAACWS on Twitter or will be tagged in a post on Facebook. Each potential winner will be required to respond to the Sponsor via direct message or private message to www.facebook.com/NCAACWS and provide his/her full name, email address and other contact information to Sponsor within forty-eight (48) hours of notification. Potential winners may be required to execute and return an affidavit of eligibility, a liability release and, where lawful, a publicity release within five (5) days of issuance.
